

# TERMS AND CONDITIONS

# **1.1 Assessment Before Enrollment**

Prior to enrolling your child in our programs, all children are required to undergo an assessment. This assessment is carefully crafted to offer parents valuable insights into their child's current level of gross motor skills and areas that hold potential for improvement. Our assessment employs the MATCH algorithm, meticulously derived from a comprehensive database of Asian children aged 2.5 to 6.0 years old. This evaluation aims to provide parents with a clear understanding of their child's abilities and to chart a collaborative path for their child's enhanced development.

# Assessment Fee

An assessment fee of \$38 using our licensed MATCH Protocol is applicable for each child undergoing the evaluation process. This fee covers the costs associated with conducting the assessment. The assessment fee is a one-time payment and is non-refundable. Fee shall be waived should your child sign up with us for our regular programme.

### Assessment Process

During the assessment, our experienced instructors will interact with your child to understand their skills, physical abilities, and comfort levels in a sports environment. The assessment is designed to provide parents with valuable feedback about their child's gross motor skills and areas for potential growth.

### Assessment Booking

To book an assessment for your child, please contact our enrollment team. We will provide you with available assessment slots and guide you through the scheduling process.

### 1.2 Registration

For children under 21 years of age, parents are required to complete the registration forms.

### **1.3 Payment & Payment Options**

All fees are to be made payable to "MatchPlay Enrichment". Enrollment will be confirmed upon receipt of full payment. Full payment must be received before the first lesson or prior to the start of the new term.

Fees for students joining after the term begins, will be prorated based on remaining lessons.

**Power of Play Program** will be offered after the assessment. Parents will be advised accordingly after the assessment and how the programme will improve the child movement literacy skills in all sports.

# 1.4 Make-up Lessons / Missed Class Policy



Make-up classes can be used when students are not able to attend classes due to sick leave (MC) or overseas holiday.

• We will arrange up to 2 additional make up slots per term (subject to availability) to maximize convenience for all our parents and child. The details of each term's make-up classes will be released prior to the start of each term.

# **1.5 Credits and Forwarding**

Credits can be carried forward to the next term if your child is on medical leave for more than 2 consecutive weeks.

# **1.6 Conduct & Requirements**

Punctuality is essential; latecomers will not be offered make-up classes. Parents are advised not to stand near the activity area during classes, unless it is a Parent-child interaction program.

### 1.7 Withdrawal & Refund

Fees paid are non-refundable and non-transferable.

At least 4 classes' notice is required for withdrawal; shorter notice may incur additional charges.

# 1.8 General

Requests for class time changes will be considered based on availability and management approval.

Terms and conditions are subject to change without prior notice.
